Interventions for Advanced learners

- Encouraging the advanced learners to involve themselves in research projects, quality publications & participation in National/ International Conferences.
- Providing opportunities to participate in case studies, debates, group discussions, technical quizzes and presentations so as to develop analytical and problem solving abilities in them and thereby, to improve their presentation skills.
- Encouraging them for Startups by providing the technical assistance.
- Mentors motivating them to get higher levels of personality development and stress management trainings.
- Making the group with the slow learners to support them.

Guidelines for Slow learners

- · Conduct extra classes for the difficult subjects in the curriculum.
- Conduct the corrective classes for the slow learners based on the results of class tests.
- Providing Lecture notes/course materials.
- Give special attention to the slow learner students in the tutorial classes.
- Specific counseling by the mentor, subject expert and T & P Cell.
- Training on life skills like communication skills, personality development, time management and motivational techniques.
- Encouraging the group activities along with fast learners.
