Provided service under the MOU shall be resumed as soon as practicable, after such event come to an end or cease to exist.

5. COMPLIANCES OF LAWS:

Both the parties shall perform their roles in strict compliance with all applicable law in India along with rules and regulations of the Government as applicable.

6. CONFIDENTIALITY:

The parties agree to keep the agreement in the strict confidence and not disclose to any third party or use of any purpose (other than in connection with this MOU) any information relating to the other's business which is marked "Confidential".
