
AND

1. Purpose

This MOU sets forth the terms and understanding between the Parties to collaborate in the design, execution, and delivery of the following services for students of Party No. 2:

- Mentoring Minds programs which includes Psychometric test with 1:1 counseling session



2.1 Party No. 1 shall be responsible for:

- Measuring student engagement and feedback

2.2 Party No. 2 shall be responsible for:

- Coordinating with internal departments for student participation
- Providing necessary logistical support including venue, equipment, and attendance
- Promoting student participation and ensuring discipline during sessions


3. Duration

This MOU shall be valid for a period of one year, commencing from the date of signing. It may be extended through mutual written agreement.

4.1 Training Fees: The Parties shall mutually agree upon fees for each module/workshop/program in writing prior to delivery.

4.2 All-inclusive Pricing: All expenses related to trainer remuneration, session design, and delivery are included in the quoted package price. No separate reimbursement for travel, accommodation, or logistical expenses will be required from Party No. 2 unless otherwise mutually agreed in writing.

Both Parties agree to maintain confidentiality regarding all student data, institutional practices, and any proprietary content shared or created under this MOU. This clause shall survive the termination of the MOU.





6. Termination
