### 3. Action Plan for 2022-23

- i. Principal Dr. Manoj K. Singh reiterated to all the members to ensure that "Ragging in all its forms is totally banned in the entire institute. The institute shall take strict action against those found guilty of ragging and/or of abetting ragging".
- ii. It was told that all the members are required to interact with the staff regularly to brief them about the provisions of the act and Squad shall make regular and surprise visits to mess, hostels, corridors, play grounds and other vulnerable places.
- iii. Names of committee members and all the provisions are to be displayed at prominent places and ensure their wide- dissemination.
- iv. It was also suggested to inform to students about the strict consequences of ragging.
- v. The institute shall organize various awareness drive through
  - Introducing the Anti-Ragging Committee and Anti Ragging Squad & their provisions to all the students in the Orientation Program.
  - Workshops on Anti ragging.
  - Anti-ragging awareness drives on regular basis through regular interaction and counseling with the students.
  - Videos related with ill effects of ragging" to be shown.
- vi. Take the affidavits from every fresher and his/her parents as per norms.
- vii. It was also informed to ensure swiftly and promptly the redressal of grievances, if any arising out of ragging.

The committee approved the action plan for 2022-23 after detailed discussion.
