



## MEMORANDUM OF UNDERSTANDING (MoU)

This memorandum of understanding is entered on **5th Aug 2025** between **From Mangalmay Institute Of Management Technology Greater Noida** through its **Vice Chairman Dr. Aayush Mangal** (hereinafter called "College" or "First Party" which expression shall where the context so admits include its successors and permitted assignees)

And

5. The First Party agrees that during the course the second party shall provide information/ documents/ records/ Proprietary Information's and confidential information to the Fecivryl Certified Professional, and it is understood that the Second party shall always have ownership of the same and the ownership of intellectual rights if any, shall remain with Second Party
6. The First party agrees that the work, product, etc. including, but not limited to all and any information and other intangible and tangible material of any nature whatsoever provided by the Second Party for use by student or First Party shall be the sole and exclusive property of the Second Party. The First Party shall be not entitled to make absolutely any use of any of the materials except as may be expressly permitted in writing by the Second Party.

### Second Party:

1. Pidilite will Offer relevant content which will be finalized under consultation with the institute faculties.
2. Pidilite will offer workshops to students/faculty staff without any charges.
3. Pidilite will arrange for an independent skilled Fecivryl Certified Professional who will conduct the training sessions throughout the duration of the training. The Fecivryl Certified Professional is an independent entity and not in the roll of Pidilite Industries.
4. Pidilite will provide Co-branded certificates & Prizes for students on successful competition of the training program.
